based on section 15(4) in connection with the section 13(2)(m) of the Act No. 250/2012 Coll. on the regulation in network industries, as amended and Article 18(5) of the Regulation (EU) 2024/1789 of the European Parliament and of the Council of 13 June 2024 on the internal markets for renewable gas, natural gas and hydrogen, amending Regulations (EU) No 1227/2011, (EU) 2017/1938, (EU) 2019/942 and (EU) 2022/869 and Decision (EU) 2017/684 and repealing Regulation (EC) No 715/2009 (recast) that for the transmission system operator **eustream**, **a.s.**, Votrubova 11/A, 821 09 Bratislava, Company ID 35 910 712 **approved an exemption**

- not to apply a discount from tariffs for renewable gas and low-carbon gas at entry points from renewable gas and low-carbon gas production facilities and capacity-based transmission tariffs at entry points from and exit points to natural gas storage facilities as determined in the Article 18(1) of the Regulation (EU) 2024/1789 of the European Parliament and of the Council of 13 June 2024 on the internal markets for renewable gas, natural gas and hydrogen, amending Regulations (EU) No 1227/2011, (EU) 2017/1938, (EU) 2019/942 and (EU) 2022/869 and Decision (EU) 2017/684 and repealing Regulation (EC) No 715/2009 (recast) from the date of delivery of this decision until 31 December 2027,
- 2. not to apply a discount on the capacity-based tariff for renewable gas and low-carbon gas at interconnection points between Member States as determined in the Article 18(4) of the Regulation (EU) 2024/1789 of the European Parliament and of the Council of 13 June 2024 on the internal markets for renewable gas, natural gas and hydrogen, amending Regulations (EU) No 1227/2011, (EU) 2017/1938, (EU) 2019/942 and (EU) 2022/869 and Decision (EU) 2017/684 and repealing Regulation (EC) No 715/2009 (recast) from 5 August 2025 until 31 December 2027.
