

Commission Regulation (EU) 2017/460 of 16 March 2017 establishing a network code on harmonised transmission tariff structures for gas (hereinafter referred to as "TAR NC")

Art. 30(1)(c)(iii) of the TAR NC – Information on the reference prices and other prices applicable at points other than those referred to in Article 29 TAR NC

In line with the Article 30(1)(c)(iii) of the TAR NC the following information should be published:

"the reference prices and other prices applicable at points other than those referred to in Article 29"

For the tariff period beginning on 1 January 2025, in connection with the information according to Article 30(1)(c)(iii) of the TAR NC, the price decision of the Regulatory Office for Network Industries No. 0001/2025/P as of 5 June 2024 is the basis. Pursuant to the given price decision, the Regulatory Office for Network Industries determined the indicative reference prices and, on the basis thereof, the final reference prices after benchmarking adjustment for all entry/exit points of the transmission system of eustream, a.s. (point 4). However, the Regulatory Office for Network Industries also stated that according to Article 2(1) of the TAR NC, the final reference prices for non-EU interconnection points (entry/exit point Veľké Kapušany, entry/exit point Budince and entry/exit point Domestic point) may not serve as the reserve prices for yearly standard capacity products for the these points, as the Regulatory Office for Network Industries did not take a decision to apply Commission Regulation (EU) 2017/459 of 16 March 2017establishing a network code on capacity allocation mechanisms in gas transmission systems and repealing Regulation (EU) No 984/2013 at those entry/exit points. The reserve prices for the above-mentioned entry/exit points will be determined on the basis of the final reference prices and the relevant legislation of the Slovak Republic.

Following the mentioned above it applies that for the period beginning from 1 January 2025 to 31 December 2027, the prices for access to the transmission network and gas transmission, as well as the conditions of their application for entry/exit points Veľké Kapušany, Budince and Domestic point have been set by the price decision of the Regulatory Office for Network Industries No. 0002/2025/P as of 5 June 2024 which amends the price decision of the Regulatory Office for Network Industries No. 0031/2023/P as of 13 February 2023. According to § 14(12) of Act No. 250/2012 Coll. of 31 July 2012 on regulation in network industries, as amended and supplemented by certain acts, the price decision for the first year of the regulatory period is valid for the entire regulatory period, unless the Regulatory Office for Network Industries approves the change of the price decision.
